

SERVICE DESCRIPTION FORTIEDGE CLOUD

1. Introduction

FortiEdge Cloud is a cloud-based management platform offering zero touch deployment, configuration management, reporting and analytics for standalone FortiAP[™], FortiSwitch[™], and FortiExtender[™] deployments (the "Service"). The Service offers management capabilities for any combination of FortiAP, FortiSwitch, or FortiExtender units (the "Deployed Devices") regardless of volume. The Service centralizes the lifecycle management of standalone FortiAP, FortiSwitch, and FortiExtender units with a simple and intuitive cloud interface allowing Customers to deploy, configure, monitor, troubleshoot, and optimize their deployment.

The Service is hosted on the FortiCloud[™] service portal whose features, deliverables and terms of use are described in the then-current FortiCloud service description made available at <u>https://support.fortinet.com/Information/DocumentList.aspx</u> (the "FortiCloud Service Description"). The terms of the FortiCloud Service Description are incorporated herein by reference and in the event of a conflict, this service description shall prevail over the FortiCloud Service Description.

2. Service Features and Deliverables

The Service targets an uptime of 99.9% each calendar month. Through the registration and activation of applicable service contracts, during the entitlement period, the Service shall provide the Customer with:

- Zero Touch Deployment The Customer is able to deploy their Deployed Devices through the FortiEdge portal (<u>https://fortiedge.forticloud.com</u>).
- Device Provisioning Customers can directly provision their Deployed Devices from the FortiEdge portal (<u>https://fortiedge.forticloud.com</u>), with centralized management of security and wireless units, and associated units.
- Robust Monitoring Network health, including Customer wifi status, is displayed through comprehensive dashboards.
- Scalability FortiEdge's cloud infrastructure is capable of bringing online a handful of Deployed Devices or thousands.
- Multi-Tenancy The Service supports the creation and organization of multiple, independent sub-account created by the Customer and Managed Security Service Providers (MSSPs) through FortiCloud.
- Public Rest API Configure, manage, and monitor Deployed Devices using API commands.
- Flexible Licensing The Service is available through a free subscription (the "Freemium License") or paid Service License:

3. Customer Required Contributions and Responsibilities

In addition to the Customer required contributions and responsibilities included in the FortiCloud Service Description, the Customer agrees, for the duration of the Service, to:

 Register all devices intended to be used with the Service through the FortiCare portal (<u>https://support.fortinet.com</u>).



4. Scope and Conditions

In addition to the scope and conditions included in the FortiCloud Service Description, the following terms apply:

- FortiEdge Cloud service is available in English, Japanese, Spanish, and Portuguese.
- Use of FortiExtender units requires a purchased license for the Service, and FortiExtender support is not available for Freemium accounts.
- Access to the Service and associated data is retained for sixty (60) days upon contract expiration date (the "Grace Period"). This Grace Period applies to any product with a valid license that is expiring. After the Grace Period, the system will randomly apply the Freemium License up to a maximum of fifteen (15) FortiAP's and one (1) FortiSwitch with a valid license that is expiring. Any other product will not be able to connect to the Service but can retain their configuration.

- 5. Eligibility & Purchasing

The Service is available for purchase by an end-customer including, as the case may be, a Fortinet authorized MSSP (the "Customer") through authorized Fortinet resellers and distributors (the "Channel Partners"). Channel Partners are independent third parties that conduct business in their own name and account and, consequently, cannot bind Fortinet in any way. The Service is delivered to the Customer as referenced in the purchase order placed with Fortinet by a Customer or a Channel Partner. This Service is separate from any purchase of other Fortinet's products or other services.

The date of the Service registration determines the start date of the Service which will run for the period determined by the Service SKU purchased by Customer notwithstanding if the Service entitlements are not fully consumed. The registration and delivery of the Service covered by this service description must commence in accordance with service activation policies made available at https://www.fortinet.com/corporate/about-us/legal, failure of which, will result in, as the case may be, the Service being partially or completely forfeited without any right to obtain a refund. In no circumstances will the duration of the Service be extended. All sales are final.
